### **CASE CHALLENGE**

The Roundtable co-hosts the <u>Annual DC Regional Public Health</u> <u>Case Challenge</u> along with the National Academy of Medicine. This problem-based learning opportunity engages multi-disciplinary teams of students in developing solutions that use the socioecologic model of health as a starting point.

The 6<sup>th</sup> annual case challenge event took place October 14, 2018, and was titled Reducing Disparities in Cancer and Chronic Disease: Preventing Tobacco Use in African American Adolescents. Six DC-area university teams competed, and the team from University of Maryland, Baltimore, won the Grand Prize. The 2018 judges included experts from the Association of American Medical Colleges, American Cancer Society; Campaign for Tobacco-Free Kids; Johns Hopkins Bloomberg School of Public Health; and the American Dental Education Association.
