CASE CHALLENGE

The Roundtable co-hosts the <u>Annual DC Regional Public Health</u> <u>Case Challenge</u> along with the National Academy of Medicine. This problem-based learning opportunity engages multidisciplinary teams of students in developing solutions that use the socioecologic model of health as a starting point.

The 7th annual case challenge event took place October 18, 2019, and w as titled 2019 Case: Reducing Health Disparities in Maternal Mortality by Addressing Unmet Health-Related Social Needs. The team from University of Maryland, Baltimore, w on the grand prize The teams from George Mason, How ard, and George Washington University, respectively, won three topical prizes. The judges for the 2019 competition included experts from the March of Dimes, the DC Maternal Mortality Review Committee, Moms Rising, the Association of American Medical Colleges, and the Council on Social Work Education.
